“Laugh Your Pants Off” Facebook competition Terms and Conditions:

### **Promotion**

1. ‘Laugh Your Pants Off Ticket Giveaway’ (“**Promotion**”) will be conducted via The Star Gold Coast’s Facebook Account: facebook.com/thestargc
2. The Promotion will commence on Thursday May 11, 2017 at 10:00am and close Thursday May 18, 2017 at 10:00am (“**Promotion Period**”). All times are listed in Australian Eastern Standard Time.

### **Entry requirements**

3. To be eligible to participate in the Promotion, during the Promotion Period, a person must :
  - (a) be 18 years of age or older;
  - (b) not be the subject of an exclusion direction or a self-exclusion order pursuant to the *Casino Control Act 1982* (Qld); and
  - (c) Be a resident of Queensland.

A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.

4. The Promoter reserves the right to refuse any person participation in the Promotion at any time in its absolute discretion.

### **Entry into the promotion**

5. To enter the Promotion, Eligible Entrants must comment on the related The Star Gold Coast Facebook Post and “Name a show or comedian that you would like to see at The Star.”
6. Responses must be received by the Promoter during the Promotion Period. Eligible Entrants can enter as many times as they like. Entries must be submitted by the individual entrant and any automated entries will be invalid.
7. On Thursday May 18, 2017 at 10:00am the Promoter will select from all valid Entries into the Competition one (1) prize winner, based on the creativity of their Entry, to be awarded as the Competition prize winner (the “**Winner**”).
8. A representative from The Star Gold Coast’s Marketing Department will be appointed to judge all Eligible Entrants’ Entries at the offices of the Promoter, The Star Gold Coast, Broadbeach, Queensland 4218.
