

THE STAR GOLD COAST'S "SPIN THE WHEEL PROMOTION" TERMS AND CONDITIONS

PROMOTIONAL PERIOD

1. The Star Pty Limited ABN 25 060 510 410 ("**The Star Gold Coast**") is the promoter of the "SPIN THE WHEEL" promotion ("**Promotion**") which commences at 5:30pm Friday 15 March 2019 and ends at 10:00pm Sunday 6 October 2019.
2. Eligible Entrants can enter the promotion during individual promotional periods ("**Entry Periods**") advertised by the promoter on dates between March 2019 and October 2019.

ELIGIBILITY

THE STAR GOLD COAST'S "\$1000 COMPETITION" TERMS AND CONDITIONS

PROMOTIONAL PERIOD

31. The Star Entertainment Qld Limited ABN 78 010 741 045 ("**The Star Gold Coast**") is the promoter of the "\$1000 CASH COMPETITION" promotion ("**Promotion**") which commences at 9:00am Friday 15 March 2019 and ends at the conclusion of the 2019 National Rugby League (NRL) Grand Final scheduled for Sunday 6 October 2019 ("**Promotional Period**"). All times listed is Australian Eastern Standard Time.
32. Eligible Entrants can enter the Promotion during individual promotional periods (each an "**Entry Period**") which will be advertised by the Promoter at the Venue on dates determined by the Promoter (28 x Friday Night NRL matches, 3 x State of Origin matches and the 2019 NRL and AFL Grand Finals) during the Promotional Period.

PARTICIPATING VENUE

33. The Promotion will be held at Sports Bar at The Star Gold Coast ("**Venue**")

PRIZES

34. The total prize pool value for the Promotion is \$32,000 comprising 28 x individual \$1,000 prizes for Friday Night NRL, 3x \$1,000 State of Origin prizes, 1x \$2,500 prizes for the 2019 NRL Grand Final and 1x \$2,500 prize for the 2019 AFL Grand Final.
35. Each prize ("**Prize**") consists of either \$1,000 in cash or \$2,500 in cash.

 - a) “**Draw One**” will take place at half time of the NRL Match where one Entry will be drawn; and
 - b) “**Draw Two**” will take place at full time of the NRL Match where one Entry will be drawn.
45. The name of each Prize Participant noted on a drawn Entry will be announced at the Venue, following which each Prize Participant will have four (4) minutes to present themselves to the person conducting the Promotion at the Venue and provide valid identification in accordance with clause 20.
