Promotion

2. The Promotion will commence on Monday 14 May, 2018 at 5:00pm and close Monday 28 May, 2018 at 10:00am (“**Promotion Period**”). All times are listed in Australian Eastern Standard Time.

Entry requirements

3. To be eligible to participate in the Promotion, during the Promotion Period, a person must :
