The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Star Gold Coast, Broadbeach Island, Broadbeach, Queensland 4218, (07) 5592 8100 (the "Promoter").
Item 2: Promotion	VIP Gold Tuesdays Wristband Draws – June 2023 (the "Promotion").
Item 3: Participating Property	The Star Gold Coast
Item 4: Promotion Period	The Promotion will commence at 4.00pm on Tuesday 6 June 2023 and will end at the conclusion of the 7.00pm draw on Tuesday 27 June 2023. All times are listed in Australian Eastern Standard Time.
Item 5: Entry Requirement	<p>Participation in the Promotion is open to all persons who:</p> <ul style="list-style-type: none"> a) Are 18 years of age or older; b) Are entitled to access one or all Draw Locations; c) Not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); d) Not the subject of a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane; and e) Are a Member of The Star Club with either: <ul style="list-style-type: none"> I. a Gold Tier active membership card, or II. a Bronze or Silver active member of The Star Club attending as a guest of an active 'Gold' member; <p>(each an "Eligible Entrant").</p> <p>People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as "Eligible Entrant/s" and will be entitled to enter the Promotion.</p> <p>The Promoter reserves the right to refuse any person participating in the Promotion at any time.</p> <p>"Invalid Entrant" means an entrant whose The Star Club membership status is cancelled during the Promotional Period or an entrant that is not an "Eligible Entrant" for the duration of the Promotional Period. Invalid Entrants will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize.</p>
Item 6: Entry Into Draws	<p>Eligible Entrants will be issued one (1) Wristband Entry during their visit to Oasis between 4.00pm and 6.55pm on a Draw Day. Eligible Entrants can receive a maximum of one (1) Wristband Entry on a Draw Day.</p> <p>The Eligible Entrant will need to securely place the Wristband onto their own wrist, detach the entry ticket from the Wristband ("Entry Ticket") and place it into the barrel at the Draw Location.</p> <p>Entry Tickets can be placed into the Barrel up to one (1) minute prior to each draw.</p> <p>Each Wristband will show a corresponding entry number ("Entry Number") to the detached Entry Ticket. The Wristband must remain intact on the Eligible Entrant's wrist to remain valid ("Valid Wristband").</p>

<p>Item 7: Draw Details</p>	<p>Wristband Draws (also referred to as “Barrel Draws”) will take place at 5.00pm, 5.30pm, 6.00pm, 6.30pm and 7.00pm on the following days:</p> <ul style="list-style-type: none"> a) Tuesday 6 June 2023 b) Tuesday 13 June 2023 c) Tuesday 20 June 2023 d) Tuesday 27 June 2023 <p>(each a “Draw Day”)</p> <p>At each Barrel Draw, two (2) Entry Tickets will be randomly drawn from the Barrel at the Draw Location.</p> <p>The Entry Numbers shown on the Entry Tickets will be announced at the Draw Location to find the Eligible Entrants with the Valid Wristbands showing the correct corresponding Entry Numbers (a “Selected Winner”).</p> <p>The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of The Star Gold Coast.</p> <p>The Selected Winners must be Present at the Relevant Draw to be eligible to win a prize. If a Selected Winner is not Present at the Relevant Draw, Item 10 will apply and that Entry Ticket will not be placed back into the Draw Barrel.</p>
<p>Item 8: Draw Location</p>	<p>Oasis Gaming Room – The Star Gold Coast</p>
<p>Item 9: Present at Draws</p>	<p><u>“Present at the relevant Draw”</u></p> <p>To be eligible to claim a Prize, Selected Members must present themselves to a representative of the Promotor at any Customer Services Desk or to the Draw Location within five (3) minutes of their name being announced and provide suitable identification.</p> <p>If an Eligible Entrant has presented themselves to a representative of the Promoter, the representative will inform the promotions host at the Draw Location that the Eligible Entrant has presented themselves and the Eligible Entrant will have ten (10) minutes to make their way to the Draw Location and confirm their identity. The Eligible Entrant is not permitted to send a proxy to claim a prize.</p> <p>Provided that the Eligible Entrant is at the Participating Property, the Promoter reserves the right, in its absolute discretion, to either:</p> <ul style="list-style-type: none"> • extend the time limit set out in this clause for the Eligible Entrant to make their way to the Draw Location; or • waive the requirement for the Eligible Entrant to present themselves at the Draw Location, <p>if the Promoter forms the reasonable view that the relevant Eligible Entrant will be physically unable to comply with such time limit or requirement due to incapacity or any other such impairment.</p> <p>It is the responsibility of the Eligible Entrant to request such time extension or waiver from the representative of the Promoter immediately on presenting themselves to the representative of the Promoter. Time Extensions or waivers will not be granted retrospectively. If a waiver is granted by the Promoter, the Eligible Entrant must still comply with all instructions required to validate their identity, including but not limited to the conditions set out in Item 13.</p>
<p>Item 10: Prize/s</p>	<p>At each Barrel Draw there will be two (2) Selected Winners who will randomly select one (1) envelope, listing one (1) of the below prizes (each a “Prize”).</p> <p>Winners are unable to open the envelope to view the prize details before selection. Once an envelope has been selected, Winners will be unable to exchange or select a different envelope or prize.</p> <p>Prize Envelopes to be chosen on 6, 13, 20 & 27 June 2023 (Draw Days)</p>

“Not present at the relevant Draw”

If a Selected Winner is Not Present at the Relevant Draw or does not otherwise satisfy these Terms and Conditions, redraws will take place until an Eligible Entrant who satisfies the requirements of these Terms and Conditions (including by being “Present at the Relevant Draw”) is drawn for each of the relevant Draw.

Item 12: Identification

A Winner may be asked to produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize.

Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver’s licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.

The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

Item 13: Other conditions

Wristbands

Wristbands are only valid for Prize Draws on the Draw Day in which they are issued. The barrel will be emptied at the conclusion of the final draw on each Draw Day.

Removed, damaged or misplaced Wristbands may not be replaced and will be deemed a void entry. The correlating Entry number for the drawn winner, must still be clearly readable on the wristband.

No substitutions, transfers, replacement or gift receipts/exchanges

Prizes are not transferrable and cannot be substituted.

Casino Dollars

Casino Dollar Prizes will load directly to the Members account. Casino Dollars may become unavailable at any time, outside of the control of the Promoter.

Casino Dollars will expire after 180 consecutive days without a valid rating of a Member’s Star Club Membership Card.

The Star Club

Any Member found to be in breach of The Star Club Membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating in a promotion with another Members Membership Card, is subject to

	consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in **Item 5** as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:
 - (a) during the Promotion; or

15. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
16. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
17. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
