Item 4:	Promotional Period	<p>5:00pm – 10:00pm each Friday between Friday 22 March and Friday, 4 October 2024 (inclusive), as more specifically set out in Item 6 below.</p> <p>All times in these Terms and Conditions are in Australian Eastern Standard Time (AEST) unless otherwise specified.</p>
Item 5:	Eligible Entrants	<p>Participation in the Promotion is limited to persons who are, insofar as is the case for the duration of the Promotional Period:</p> <ul style="list-style-type: none"> (a) aged 18 years or over; (b) entitled to access the Venue; (c) not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited or its related entities, whether pursuant to the <i>Casino Control Act 1982</i> (Qld) or otherwise; (d) not the subject of a Withdrawal of License from the Promoter; (e) not an Invalid Entrant; (f) not a director, officer, manager or employee of The Star Entertainment Group Limited or any of its related entities (including the Promoter); and (g) not an immediate family member (including a sibling, parent, child, grandparent, grandchild, spouse, former spouse, de facto partner or former de facto partner, including a step-relation and an adoptive relation) of any person listed in item (f) above or of their spouse, former spouse, de facto partner or former de facto partner, <p>("Eligible Entrant/s").</p> <p>If an Eligible Entrant is excluded or issued a WOL during the Promotional Period so that he or she is no longer an Eligible Entrant, that person will no longer be eligible to enter or participate in the Promotion and will forfeit any entitlement to a prize (an "Invalid Entrant").</p> <p>If, at the time of a draw, a person is restricted or prevented from entering the casino area due to a 'temporary prevention of entry' for contravention of a Playbreak rule, that person is not eligible to claim a prize (even if they are the selected winner) and that person will forfeit any entitlement to a prize.</p>

<p>Item 7:</p>	<p>Entry</p>	<p>Eligible Entrants can enter the Promotion on each Draw Day by:</p> <ol style="list-style-type: none"> a. Purchasing a Hahn Superdry product from the Venue between 5:00pm and 10:00pm on a Draw Day. The Eligible Entrant will receive an entry form to the Promotion for each Hahn Superdry product that they purchase; b. Completing all details on the entry form; and c. Placing the fully completed entry form into the barrel located at the Venue (“Barrel”) by 10pm on the Draw Day. <p>The entry form must be placed in the Barrel on the same day as the day that the entry form was received from the Venue.</p> <p>Entries, which in the reasonable opinion of the Promoter:</p> <ol style="list-style-type: none"> a. are not from an Eligible Entrant; b. are received outside the time of 5:00pm to 10:00pm on a Draw Day; c. are placed in the Barrel on a different Draw Day from the Draw Day when the entry form was received by the Eligible Entrant;

		<p>d. contain defamatory, offensive or inappropriate content or infringe intellectual property rights;</p> <p>e. are fraudulent or forged;</p> <p>f. are incomplete or indecipherable; or</p> <p>g. do not otherwise comply with these Terms,</p> <p>will be an “Invalid Entry” and will be invalid and ineligible for any prize.</p> <p>The Barrel will be closed at 10:00pm on each Draw Day during the Promotion Period.</p>
Item 8:	Entry Limits	<p>Eligible Entrants may submit multiple entries per Draw Day.</p> <p>Eligible Entrants will only be entitled to receive entry forms consistent with the Promoter’s policies and legal obligations in relation to the responsible service of alcohol. The Promoter supports and practises the responsible service of alcohol. The Promotion is at all times subject to the Promoter’s responsible service of alcohol policy. The Promoter reserves the right to refuse to serve a person and/or award an entry form if to do so would be inconsistent with the Promoter’s responsible service of alcohol policy.</p>
Item 9:	Draw	<p>On each Draw Day, the draw will take place at the Venue at or around 10pm.</p> <p>A representative of the Promoter (“MC”) will randomly select one (1) entry form from the Barrel (“Selected Person”). A representative of the Promoter will review the entry form for the Selected Person to confirm eligibility into the Promotion.</p> <p>The Selected Person will be announced live over the microphone inside the Sports Bar. The Promoter cannot guarantee that all announcements can be heard at the Sports Bar or in all parts of the property of The Star Gold Coast.</p> <p>If a drawn entry is deemed an Invalid Entrant or Invalid Entry, it will not be considered as a valid draw and an additional entry form will be drawn until a drawn entry form is not deemed to be an Invalid Entrant nor an Invalid Entry.</p> <p>For the avoidance of doubt there will be a maximum one (1) Selected Person per Draw Day.</p>

<p>Item 10:</p>	<p>Selected Person</p>	<p>The Selected Person must be present at the Venue and will have three (3) minutes to present themselves to the MC at the Venue.</p> <p>The Selected Person must show Valid ID at the time of presentation to the MC. “Valid ID” means a passport, Australian driver’s license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to the Promoter.</p> <p>The Selected Person is not permitted to send a proxy to present themselves to the MC and/or claim a prize. The Promoter reserves the right in its absolute discretion to extend the time limit set out within this clause if the Promoter forms the reasonable view that a Selected Person will be physically unable to comply with such time limit due to incapacity or any other such impairment. It is the responsibility of the Selected Person to request such time extension from the representative of the Promoter before making their way to the Draw location. Time Extensions will not be granted retrospectively.</p> <p>If the Selected Person does not present themselves within three (3) minutes of their name being drawn from the Barrel and/or does not present Valid ID, then the Selected Person forfeits the chance to spin the prize wheel and is no longer the “Selected Person” for the purposes of these terms and conditions.</p> <p>If the Selected Person forfeits their right to spin the prize wheel, the Promoter will repeat the draw process no more than three (3) times to find a Selected Person with Valid ID who has presented themselves within the time limit set out in this Item 10 (and who otherwise complies with the terms of this document).</p> <p>If no Selected Person is found after the fourth draw, there will be no Selected Person for that Draw Day.</p> <p>On completion of the draw on each Draw Day, the remaining entry forms in the Barrel will be discarded (and will not be included in any future draw).</p>
<p>Item 11:</p>	<p>Prize Wheel, Prizes and Max Prize</p>	<p>Once their identity is verified, the Selected Person will then be invited to spin the promotional wheel, ensuring a minimum of one revolution has occurred (the “Spin”), to reveal the prize won by the Selected Person. If one revolution has not occurred, the Selected Winner must spin the promotional wheel again.</p> <p>If the indicator on the promotional wheel comes to rest between 2 segments (that is, the indicator stops on a peg), the Prize in the segment that last passed the indicator before it stopped is the Prize awarded to the Selected Person.</p> <p>The promotional wheel is divided into 12 equal sections. The Selected Person will win the prize indicated on the promotional wheel after a valid Spin.</p>

General Terms and Conditions

- 1 These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information about prizes and materials on how to enter this Promotion forms part of these Terms and Conditions. By entering, you accept these Terms and Conditions.
- 2 Your entry form into the Promotion must be received on the day that the entry form is given to you. Your entry is subject to Entry Limits. If your Entry is based on participation that is reversed, cancelled or otherwise deemed invalid, or you are no longer an Eligible Entrant, your Entry into the Promotion may be deemed invalid at the Promoter's discretion. The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering. If you enter using automatically generated entries or multiple aliases you may be disqualified.
- 3 The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
- 4 If you or your Entry are deemed by the Promoter to breach these Terms and Conditions, your Entry (or at the Promoter's discretion, all of your entries) may be discarded. The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your Entry (including documentation establishing your identity, age, place of residence and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.
- 5 You must not:
 - a tamper with the entry process;
 - b. engage in any conduct that may jeopardise the fair and proper conduct of the promotion;
 - c. act in a disruptive, annoying, threatening, abusive or harassing manner;
 - d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this promotion;
 - e. breach any law; or
 - f. behave in a way that is otherwise inappropriate.
- 6 The Promoter is not liable for entries, prize claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
- 7 The Promoter's decision in connection with all aspects of this promotion is final.
- 8 The Promoter reserves the right to cancel or change any Prize offered under the Promotion if there are any changes to the law which would or might render the Promotion or any prizes offered under the Promotion unlawful.
- 9 No Prize, entry or other feature of the Promotion can be transferred or redeemed for cash, or other goods or services.
- 10 To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to: (a) make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or (b) postpone the draw/s to a time and place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw/s.
- 11 If this Promotion cannot run as planned for any reason beyond the Promoter's reasonable control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the closure of the Promoter's premises, government directives, public health orders and the like, the Promoter may end, change, suspend or cancel the Promotion or disqualify affected entries/entrants.

- 12 The Promoter may disclose your personal information, including details of winners where required or authorised to do so by or under law or the disclosure is reasonably necessary to enforce the law. This may occur under the laws that apply to the Promoter's business, for example, where a regulatory authority requests information from the Promoter.
- 13 The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. If for GST purposes this promotion results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
- 14 Should a Selected Person consent to having his/her photograph taken, that Selected Person consents to having his/her name and photograph published in any form of media and agrees to participate in any reasonable promotion requested by the Promoter, without reward.
- 15 A copy of the terms and conditions governing the Promotion can be obtained at www.thestargoldcoast.com.au for the duration of the Promotion (including each Draw Day).
- 16 If any dispute arises between an entrant of the Promotion and the Promoter concerning the conduct of this promotion or claiming a prize, the Promoter will take reasonable steps to consider the entrant's point of view, taking into account any facts or evidence the entrant puts forward, and to respond to it fairly within a reasonable time. In all other respects, the Promoter's decision is final, and no correspondence will be entered into.

Liability

- 17 Nothing in these Terms and Conditions restricts, excludes or modifies any consumer rights under any statute including the *Competition and Consumer Act 2010* (Cth).
- 18 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this Promotion are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this Promotion or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 19 The Selected Person agrees to accept, receive and use the Prize at their own risk and will, at all times, indemnify, keep indemnified, hold harmless and release the Promoter to the full extent permitted by law from and against any and all claims, causes of action, losses, damage, liability, cost or expense (including legal expenses on a full indemnity basis), incurred by the Promoter as a result of or in connection with the Promotion and from all liability which may arise in respect of any accident, damage or injury occurring to any person or property in connection with the Prize and / or the Selected Person. The Selected Person and any other person(s) nominated to share the prize with the Selected Person may be required to sign an agreement to release the Promoter from and indemnify the Promoter against any liability arising from the use or participation in the prize.
- 20 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this promotion are not liable for any loss of, damage to or delay in delivery of prizes or for any damage that occurs to prizes if/when displayed at the Promoter's premises.
