PROMOTIONAL PERIOD

PARTICIPATING VENUE

3. 24/7 Sports Bar at The Star Sydney

PRIZES

4. The total prize pool is valued at \$2,600 and consists of two prizes.
5. Prize one is a catered VIP booth package for the AFL Grand Final in 24/7 Sports Bar on Saturday 29 September 2018 for the winner and 2 friends. Valued at \$1,300. Package includes:
 - a. Reserved booth in 24/7 Sports Bar

 - c. Personal cocktail server
6. Prize two is a catered VIP booth package to the NRL Grand Final in 24/7 Sports Bar on Sunday 30 September 2018 for the winner and 2 friends. Valued at \$1,300. Package includes:

ELIGIBILITY

7. Participation in the Promotion is limited to persons who are, insofar as is the case for the duration of the Promotional Period:

 - b. not excluded from The Star Sydney; and
 - c. Reside in Australia

PARTICIPATION

JUDGING

14. The panel of judges will consist of two members from The Star Marketing Department
15. A separate judging will take place for each prize and includes;
 - a. Prize one judging will take place on 10:00am, Monday 24 September 2018
 - b. Prize two judging will take place on 10:30am, Monday 24 September 2018
16. Prize winners will be notified by 4pm on the day of judging
17. Winners will be notified via the winning Instagram Post
18. If, despite its reasonable efforts, The Promoter does not receive a confirmation by 4pm on the day following the Judging from the Prize Winner, the Prize Winner forfeits the Prize and is no longer the Prize Winner for the purposes of these terms and conditions.
19. If the Prize Winner forfeits the Prize pursuant to clause 18, the Promoter will judge a second entry in accordance with clause 13. This new Judging will take place at 5pm the day following the first judging (“Second Judging”). The promoter will take reasonable efforts to notify the Prize Winner as a result of the Second Judging via Instagram within one (1) hour of the Second Judging. Judging’s will continue in this manner until the new Winner has been notified of the result of the new Judging.

IDENTIFICATION REQUIREMENTS

20. To satisfy these Identification Requirements, an Eligible Entrant must:
 - a. Email identification that is valid and acceptable to the Promoter (“Valid ID”)

Valid ID means:
 - b. a passport, Australian driver’s license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to the Promoter; or
 - c. One form of non-photographic identification that are valid and acceptable to the Promoter.

GENERAL

22. The promotion is not sponsored, endorsed or administered by, or associated with, Instagram.

23. Transport will not be supplied to and from The Star for the winners
