

**“HAMILTON TICKET GIVEAWAY COMPETITION”
TERMS AND CONDITIONS**

1. The Star Pty Limited ABN 25 060 510 410 (“**The Star Sydney**”) is the promoter of the “HAMILTON TICKET GIVEAWAY COMPETITION” (“**Promotion**”) which commences from 5:00pm AEST Wednesday, 24 March 2021 and ends at 12:00pm AEST on Wednesday, 31 March 2021 (“**Promotional Period**”).

ELIGIBILITY

2. Participation in the Promotion is limited to persons who, insofar as is the case for the duration of the Promotional Period:
 - a. 18 years of age or over;
 - b. Must be available to attend the show at 2:00pm on Saturday, 10 April 2021;
 - c. Not excluded from The Star Entertainment Group; and
 - d. Resides in New South Wales, Australia.
3. The promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including the following entries (“**Invalid Entries**”):
 - a. An Entry from a person who is not an Eligible Entrant;
 - b. An Entry that does not have the Eligible Entrant’s full details on it;
 - c. An Entry that is fraudulent or forged; and
 - d. An Entry that appears to have been tampered with.
4. Invalid Entries cannot win the prize.

PARTICIPATION

5. To enter the Promotion, Eligible Entrants must:

6. The Star Sydney reserves the right to verify the validity of any Entry. The Star Sydney may, in its sole discretion, disqualify any Entry from, and prohibit further participation in this Promotion by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Promotion and reserves the right to disqualify any entry which is not submitted in accordance with these conditions of entry.
7. No Entry will be accepted after 12:01pm AEST on Wednesday, 31 March 2021.

PRIZE INCLUSION

8. There will be a maximum of one (1) Prize Winner for this promotion. The Prize Winner will win:

- a. 1 x Double Pass tickets to see the musical "Hamilton" at 2:00pm on Saturday, 10 April 2021
9. For the avoidance of doubt, the Prize does not include change of seating requests, and the Promoter is not responsible for any additional seating change charges. These charges will be billed to the Prize Winner separately and at their advertised rates.
10. This prize package can only be redeemed within the duration of the selected dates (refer to clause 8a). The maximum prize pool of this promotion is AU\$600.
11. Prizes are not transferable or exchangeable and are subject to the terms and conditions.

DRAW

12. There will be a prize draw ("**Prize Draw**") at 4:00pm Wednesday, 31 March 2021. The Prize Draw will be held at Level 2, 60 Union Street Pyrmont at The Star Sydney ("**Main Draw Location**"). Eligible Entrants are not required to be physically present at the Main Draw Location.
13. At the Prize Draw, one (1) Entry will be randomly selected from the entrants ("**Drawn Entry**") by a representative of Promoter. A representative of Promoter will review the Drawn Entry to confirm eligibility into the Promotion.
14. If a Drawn Entry is deemed an Invalid Entrant or Invalid Entry, it will not be considered as a valid draw and an additional Entry will be drawn until a Drawn Entrant is not deemed to be an Invalid Entrant nor an Invalid Entry ("**Prize Winner**").

NOTIFICATION OF WINNER

15. A representative of the Promoter will use reasonable efforts to contact the Prize Winner within forty-eight (48) hours of the Prize Draw and organize prize collection. The Prize Winner must produce Valid ID that is valid and acceptable to the representative of the Promoter in order to claim their prize.

"Valid ID" means:

- a. a passport, Australian driver's license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to The Star Sydney; or
 - b. One form of non-photographic identification that are valid and acceptable to The Star Sydney.
16. The promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Winner is determinable by a representative of the promoter without the assistance of these or any other form of identification.

will be deemed to have forfeited the prize in whole, no substitute will be offered and is an invalid selection (“**Invalid Selection**”).

REDRAWS

18. If a Drawn Entrant is considered an Invalid Selection, a redraw will occur with existing Entries. The Promotor will endeavour to inform Eligible Entrants who have Entries to the Prize Draw about redraw details through Instagram and Facebook.
19. Re-drawn entrants will have 24 hours to claim their prize. This process will be repeated until a Prize Winner is found.

GENERAL

20. The promotion is not sponsored, endorsed or administered by, or associated with, Instagram.
21. Except as expressly provided in these terms and conditions, Entries and the Prize cannot be redeemed for cash or other goods and services.
22. The promoter reserves the right to cancel or change the prizes offered under the Promotion if there are any changes to the law that would or might render the Promotion or any prizes offered under the Promotion unlawful.
23. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the promoter. The promoter’s decisions in relation to the conduct of the Promotion are final.

insulting, scandalous, inflammatory or defamatory images or language. The judges' decision is final and no correspondence will be entered into. Chance plays no part in determining the winner.

The promoter is not responsible for any loss, damage or injury suffered or claimed, including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the promoter or the willful or negligent acts or omissions of the promoter. To avoid any doubt the promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the promoter.

If for any reason this competition is not capable of running as planned for any reason beyond the Promoter's control, including but not limited to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the promoter which corrupt or affect the administration security, fairness, integrity or proper conduct of this competition, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the competition.
29. To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to (a) make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or (b) postpone the draw/s to a time and place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw/s.
30. The promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of, entries.
31. The promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any email or entry to be received by the promoter on account of technical problems or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any materials in this competition.

The Prize Winner and any other person(s) nominated to share the Prize with the Prize Winner agrees to accept, receive and use the Prize at their own risk and will, at all times, indemnify, keep indemnified, hold harmless and release The Star Sydney to the full extent permitted by law from and against any and all claims, causes of action, losses, damage, liability, cost or expense (including legal expenses on a full indemnity basis), incurred by The Star Sydney as a result of or in connection with the Promotion and from all liability which may arise in respect of any accident, damage or injury occurring to any person or property in connection with the Prize and / or the Prize Winner.
