

## “STAR ENTERTAINMENT GROUP – SPORTS PROMOTION” THE STAR SYDNEY

### TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Brown-Forman Australia Pty Limited (ABN 87 000 064 086) of Level 6, 280 Elizabeth Street, Surry Hills, NSW 2010, telephone (02) 9764 8777 (“**Promoter**”).
3. Entry is only open to residents of Australia aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, The Star Entertainment Group and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
5. Entries into the promotion open on 01/12/2020 and close at 9pm (local time) on 09/02/2021 (“**Promotional Period**”). This promotion will only be conducted at The Star Sydney (“**Participating Venue**”).
6. To enter, individuals must complete the following steps during the Promotional Period:
  - a) Purchase any Jack Daniel’s drink from the Participating Venue (“**Qualifying Transaction**”). Upon making their Qualifying Transaction, individuals will then be provided with a promotional entry flyer (“**Entry Flyer**”), while stocks last. In the event an Entry Flyer is not automatically provided to them, it is the individual’s responsibility to request one; and then
  - b) Fully complete the Entry Flyer and place the completed Entry Flyer into the entry box provided at the Participating Venue (“**Initial Entry**”).
7. In addition to the above, individuals that make a Qualifying Transaction will be given the opportunity to play a game for the chance to win an instant win prize. Individuals will be presented with a QR Code at the time of making their Qualifying Transaction, Individuals must, using a smart phone, scan the QR Code to view a spinning wheel. Individuals must then press the “Spin to Win” Button to reveal if they have won an instant win prize. Winners of an instant win prize must simply present their winning screen to the staff member who presented them the QR Code to receive their prize. Instant win prizes to be won are as follows:
  - 1000x Jack Daniel's Caps valued at \$10 each;

9. Incomplete, indecipherable or illegible entries will be deemed invalid.

Multiple entries permitted, subject to the following: (a) only one (1) Initial Entry permitted per Qualifying Transaction (regardless of the number of Jack Daniel’s products purchased in that transaction in excess of one (1)); (b) only one (1) Bonus Entry is permitted per Qualifying Transaction; (c) each entry must be submitted separately and in accordance with entry requirements; and (d) a maximum of two (2) entries are permitted per person per day (i.e. one (1) Initial Entry associated with a Qualifying Transaction and one (1) Bonus Entry permitted per person per day).

any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. 14. The Promoter's decision is final and no correspondence will be entered into.
