

“THE STAR ENTERTAINMENT GROUP – SPORTS PROMOTION”

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Brown-Forman Australia Pty Limited (ABN 87 000 064 086) of Level 6, 280 Elizabeth Street, Surry Hills, NSW 2010, telephone (02) 9764 8777 (“**Promoter**”).
3. Entry is only open to NSW and QLD residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, The Star Entertainment Group and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. Entries into the promotion open on 04/11/19 and close at 9pm (local time) on 17/02/20 (“**Promotional Period**”). This promotion will only be conducted at The Star Sydney, Treasury Brisbane and The Star Gold Coast (each a “**Participating Venue**”).
6. To enter, individuals must complete the following steps during the Promotional Period:
 - a) Purchase any Jack Daniel’s drink from a Participating Venue (“**Qualifying Transaction**”). Upon making their Qualifying Transaction, individuals will then be provided with a promotional entry flyer (“**Entry Flyer**”), while stocks last. In the event an Entry Flyer is not automatically provided to them, it is the individual’s responsibility to request one; and then
 - b) Fully complete the Entry Flyer and place the completed Entry Flyer into the entry box provided at the Participating Venue.
7. Incomplete, indecipherable or illegible entries will be deemed invalid.
8. Multiple entries permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the number of Jack Daniel’s products purchased in that transaction in excess of one (1)); (b) each entry must be submitted separately and in accordance with entry requirements; (c) a maximum of two (2) entries per person per day is permitted in QLD; and (d) a maximum of one (1) entry per person per day is permitted in NSW.
9. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
10. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
11. Entries from each Participating Venue will be combined for the draw to determine one (1) winner.
12. The draw will take place at The Star Sydney, 80 Pyrmont Street, Pyrmont NSW 2009 at 8pm AEDST on 25/02/20. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
13. The Promoter’s decision is final and no correspondence will be entered into.

14. The winner will be notified by telephone and email within two (2) business days of the draw and their name will be published online at <http://www.jackspromo.com.au/star/winner> from 28/02/20.
15. The first valid entry drawn will win a trip for two (2) adults to Nashville, Tennessee (USA), valued at up to AU\$15,000 depending on date and point of departure. Prize includes:
 - Two (2) x return economy airfares from winner's nearest capital city to Nashville, Tennessee;
 - Return transfers between airport and accommodation;
 - Seven (7) nights twin share minimum 4 star accommodation;
 - Jack Daniel's distillery tour for two (2);
 - Return transfers between accommodation and Jack Daniel's distillery; and
 - Two (2) tickets to an American baseball game and/or American football game (exact tickets to be awarded will be based on when the prize is redeemed and is to be determined by the Promoter in its absolute discretion).
16. The legal drinking age in Nashville, Tennessee is 21 years of age. In the event the winner and/or his/her companion are aged under 21 years, they can still participate in the Jack Daniel's distillery tour however they will not be able to receive/sample any alcohol whilst participating in the tour. Prize must be taken by 21/02/2021 and is subject to booking and flight availability. Prize cannot be taken between 07/12/2020 and 07/01/2021, during Australian school holidays, public holidays or other peak periods. Itinerary to be determined by the Promoter in agreement with the winner but in the event that agreement cannot be reached, the Promoter reserves the right to determine the itinerary. Prize must be booked a minimum three (3) weeks prior to departure date. The Promoter and event organisers hereby expressly reserve the right to eject the winner (and/or his/her companion) for any inappropriate behaviour, including but not limited to intoxication, whilst participating in any element of the prize.

Entry and continued participation in this promotion is subject to the licensee's liquor serving policy.
19. Subject to the unclaimed prize draw clause, if for any reason the winner does not take the prize (or an element of the prize) by/at the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
