

**“SYDNEY FC JERSEY GIVEAWAY COMPETITION”
TERMS AND CONDITIONS**

1. The Star Pty Limited ABN 25 060 510 410 (“**The Star Sydney**”) is the promoter of the “SYDNEY FC SOCCER BALL GIVEAWAY COMPETITION” (“**Promotion**”) which commences from 12:00pm AEST Friday, 28 May 2021 and ends at 12:00pm AEST on Friday, 11 June 2021 (“**Promotional Period**”).

ELIGIBILITY

2. Participation in the Promotion is limited to persons who, insofar as is the case for the duration of the Promotional Period:
 - a. 18 years of age or over;
 - b. Not excluded from The Star Entertainment Group; and
 - c. Resides in New South Wales, Australia.
3. The promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including the following entries (“**Invalid Entries**”):
 - a. An Entry from a person who is not an Eligible Entrant;
 - b. An Entry that does not have the Eligible Entrant’s full details on it;
 - c. An Entry that is fraudulent or forged; and
 - d. An Entry that appears to have been tampered with.
4. Invalid Entries cannot win the prize.

PARTICIPATION

6. The Star Sydney reserves the right to verify the validity of any Entry. The Star Sydney may, in its sole discretion, disqualify any Entry from, and prohibit further participation in this Promotion by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Promotion and reserves the right to disqualify any entry which is not submitted in accordance with these conditions of entry.
7. No Entry will be accepted after 12:01pm AEST on Friday, 11 June 2021.

PRIZE INCLUSION

8. There will be a maximum of one (1) Prize Winner for this promotion. The Prize Winner will win:
 - a. A signed soccer ball valued at \$150.
9. Prizes are not transferable or exchangeable and are subject to the terms and conditions.

DRAW

10. There will be a prize draw ("**Prize Draw**") at 4:00pm Friday, 11 June 2021. The Prize Draw will be held at Level 2, 60 Union Street Pyrmont at The Star Sydney ("**Main Draw Location**"). Eligible Entrants are not required to be physically present at the Main Draw Location.
11. At the Prize Draw, one (1) Entry will be randomly selected from the entrants ("**Drawn Entry**") by a representative of Promoter. A representative of Promoter will review the Drawn Entry to confirm eligibility into the Promotion.
12. If a Drawn Entry is deemed an Invalid Entrant or Invalid Entry, it will not be considered as a valid draw and an additional Entry will be drawn until a Drawn Entrant is not deemed to be an Invalid Entrant nor an Invalid Entry ("**Prize Winner**").

NOTIFICATION OF WINNER

13. A representative of the Promoter will use reasonable efforts to contact the Prize Winner within forty-eight (48) hours of the Prize Draw and organize prize collection. The Prize Winner must produce Valid ID that is valid and acceptable to the representative of the Promoter in order to claim their prize.

"Valid ID" means:

- a. a passport, Australian driver's license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to The Star Sydney; or

REDRAWS

16. If a Drawn Entrant is considered an Invalid Selection, a redraw will occur with existing Entries. The Promotor will endeavour to inform Eligible Entrants who have Entries to the Prize Draw about redraw details through Instagram and Facebook.
17. Re-drawn entrants will have 24 hours to claim their prize. This process will be repeated until a Prize Winner is found.

GENERAL

18. Guests must be 18 years or over to enter the casino.
19. The promotion is not sponsored, endorsed or administered by, or associated with, Instagram.
20. Except as expressly provided in these terms and conditions, Entries and the Prize cannot be redeemed for cash or other goods and services.
21. The promoter reserves the right to cancel or change the prizes offered under the Promotion if there are any changes to the law that would or might render the Promotion or any prizes offered under the Promotion unlawful.

To the extent that a situation, malfunction, or other issue arises for which these Terms and Conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to (a) make a decision regarding those circumstances which is not inconsistent with these Terms and Conditions; and/or (b) postpone the draw/s to a time and place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw/s.
29. The promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of, entries.

The promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any email or entry to be received by the promoter on account of technical problems or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any materials in this competition.
