

## THE STAR SYDNEY'S "\$1000 CASH COMPETITION" TERMS AND CONDITIONS

### PROMOTIONAL PERIOD

1. The Star Pty Limited ABN 25 060 510 410 ("**The Star Sydney**") is the promoter of the "\$1000 CASH COMPETITION" promotion ("**Promotion**") which commences at 5:30pm Friday 15 March 2019 and ends at 10:00pm Sunday 6 October 2019.
2. Eligible Entrants can enter the promotion during individual promotional periods ("**Entry Periods**") advertised by the promoter on dates between March 2019 and October 2019.

### PARTICIPATING VENUE

3. 24/7 Sports Bar and FUEL at The Star Sydney.

### PRIZES

1. The total prize pool value is estimated at \$25,000.
2. This consists of 25 x individual \$1,000 cash prizes across 25 x Friday Night NRL matches
3. Each prize ("**Prize**") consists of \$1,000 in cash.

### ELIGIBILITY

4. Participation in the Promotion is limited to persons who are, insofar as is the case for the duration of the Promotional Period:
  - a. 18 years of age or over;
  - b. not excluded from The Star Sydney
5. The Promoter reserves the right, at its sole and absolute discretion, to deem any irregular entries, including the following entries, "Invalid Entries":
  - a. Entries that have not been completed properly
6. Invalid Entries cannot win the prize.

### PARTICIPATION

7. To enter the Promotion, Eligible Entrants ("**Eligible Entrants**") must purchase a Hahn Super Dry product or other promoted Lion Nathan product from 24/7 Sports Bar or FUEL in a single transaction during a promoted Entry Period
8. The promoted Lion Nathan product may change during the Promotion
9. One entry form per product purchased allowed in a single transaction.
10. Eligible Entrants can only submit one entry per draw day during the Entry Period.
11. Eligible Entrants will only be entitled to receive Entries consistent with the Promoter's policies or legal obligations in relation to the responsible service of alcohol. The Promoter supports the responsible service of alcohol. The Promotion is at all times subject to The Star's responsible service of alcohol policy. The Star reserves the right to refuse to serve a person or award an Entry if to do so would be inconsistent with The Star's responsible service of alcohol policy.
12. Eligible Entrants must complete all details required on the Entry and place it in the barrel ("**Barrel**") during the Entry Period. There will be 1 Barrel that will be located in 24/7 Sports Bar for the duration of the Entry period.

## DRAW

13. Two prize participants ("**Prize Participants**") will be drawn from the Barrel for the chance to win the Prize
14. Draw One ("**Draw One**") will take place at half time of a select National Rugby League match during the 1<sup>st</sup> Grade Premiership
15. Draw Two ("**Draw Two**") will take place at full time of the same National Rugby League match during the 1<sup>st</sup> Grade Premiership
16. Prize Participants will have four (4) minutes to present themselves to the person conducting the promotion ("**MC**") in 24/7 Sports Bar.
17. Prize Participants must show valid ID.
18. If a Prize Participant doesn't present themselves within four (4) minutes of being drawn with valid ID, the Prize Participant forfeits and is no longer a Prize Participant for the purposes of these terms and conditions.
19. If a Prize Participant forfeits pursuant to clause 18, the Promoter will draw a second entry ("**Second Participant Draw**").
20. Clause 19 will be conducted an additional time ("**Third Participant Draw**") for both Draw One and Draw Two if necessary
21. The names of Prize Participant One and Prize Participant Two will then be placed onto a spinning promotional wheel ("**Promotional Wheel**")
22. Both Prize Participants will have a 50% chance of winning the Prize
23. The person conducting the promotion will spin the promotional wheel, ensuring a minimum of one revolution has occurred. Whichever name of Prize Participant it lands on wins the Prize and becomes the Prize Winner ("**Prize Winner**").
24. If no Prize Participant is found during Draw One, Draw Two will still be conducted
25. If clause 24 comes into effect, then the Prize Participant from Draw Two becomes the winner of the Prize and clause 23 becomes redundant
26. If no Prize Participant is found for both draws, a final draw ("**Final Draw**") will take place and the winning name will be emailed and informed of the prize.

## IDENTIFICATION REQUIREMENTS

27. To satisfy these Identification Requirements, an Eligible Entrant must:
  - a. Present identification that is valid and acceptable to the Promoter ("**Valid ID**")

Valid ID means:

- b. a passport, Australian driver's license or other form of photographic identification in which the photograph is clear and undamaged and that is otherwise acceptable to the Promoter; or
- c. One form of non-photographic identification that are valid and acceptable to the Promoter.

## PRIVACY

28. The Promoter needs to collect the personal information of entrants so that the entrant can be entered into the Promotion. Without providing the Promoter with that information, the Promoter cannot enter the person in the Promotion. policy describes the purposes for which The Star Entertainment Group, including the Promoter, may collect, store, use and disclose personal information.

#### GENERAL

29. The total prize pool is estimated at \$25,000.
30. Except as expressly provided in these terms and conditions, Entries and the Prize cannot be redeemed for other goods and services.
31. The Promoter reserves the right to cancel or change the prizes offered under the Promotion if there are any changes to the law that would or might render the Promotion or any prizes offered under the Promotion unlawful.
32. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter. The Promoter's decisions in relation to the conduct of the Promotion are final.
33. To the extent that a situation, malfunction, or other issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, The Promoter reserves the right to (a) make a decision regarding those circumstances which is not inconsistent with these terms and conditions; and/or (b) postpone the draw(s) to a time and place which will allow the draw to be conducted in accordance with all terms and conditions other than those terms and conditions which specify the time and place of the draw(s).
34. The Promoter is not responsible for any loss, damage or injury suffered or claimed, including, but no limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter. To avoid any doubt the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
35. The Prize Winner and any other person(s) nominated to share the Prize with the Prize Winner agrees to accept, receive and use the Prize at their own risk and will, at all times, indemnify, keep indemnified, hold harmless and release The Star Sydney to the full extent permitted by law from and against any and all claims, causes of action, losses, damage, liability, cost or expense (including legal expenses on a full indemnity basis), incurred by The Star Sydney as a result of or in connection with the Promotion and from all liability which may arise in respect of any accident, damage or injury occurring to any person or property in connection with the Prize and / or the Prize Winner. The Prize Winner and any other person(s) nominated to share the prize with the Prize Winner will be required to sign an agreement to release The Star Sydney from and indemnify The Star Sydney against any liability arising from the use or participation in the prize.

36. Directors, management and employees of any of THE STAR ENTERTAINMENT GROUP of companies (including, without limitation, The Star Sydney, The Star Gold Coast and Treasury) and their immediate families are not eligible to participate in the Promotion.
37. Participation in the Promotion by an Eligible Entrant confirms acceptance of the terms and conditions governing the Promotion including but not limited to the indemnity and exclusion clauses contained herein.

Subject to any applicable law that cannot be excluded, the Promoter nor their related bodies corporate, shall be liable for any loss, damage or injury suffered or sustained (including but not limited to direct or consequential loss or loss arising from negligence) arising directly or indirectly out of or in connection with the Promotion or the Prize.
39. Should a prize winner consent to having their photograph taken, they consent to having their name and photograph published in any form of media and agree to participate in any reasonable promotion requested by the Promoter, without reward.
40. All monetary values expressed in this document are expressed in Australian currency.
